Eligibility, rules, terms and conditions

- New construction does not qualify
- Purchase must have been made after July 1, 2019 and before June 30, 2020
- Application forms without complete information or a valid receipt will be returned to the applicant

Water accounts which have received a rebate from Sweetwater Authority will not be eligible to receive additional rebates for similar products.

Only new fixtures or devices qualify

Equipment that is used, leased, refurbished, rented, received from warranty or insurance claims, exchanged or won as a prize do not qualify for this rebate.

Funding is limited and disbursed on a first-come, first-served basis. Rebate subject to available funds or discontinuation at any time.

PROGRAM REQUIREMENTS

Rain Sensor Rebate – The Authority will provide a rebate of up to \$25.00 towards the purchase of an irrigation controller rain sensor. Upon receipt of the application form, staff will contact the customer to schedule a site visit to verify installation occurred within the Authority’s service area. Rebate amount will not exceed the cost of the device.

Single Source Graywater Retrofit Rebate – The Authority will provide a rebate of up to \$75.00 towards the purchase and installation of a laundry-to-landscape graywater system. Upon receipt of the application form, staff will contact the customer to schedule a site visit to verify installation occurred within the Authority’s service area. Rebate amount will not exceed the cost of parts and installation.
